International Cooperation and multilateralism are indispensable

The return of brutal regime of Taliban in Afghanistan after 20 years of ~~the~~ inconclusive war has been considered as the biggest failure of international cooperation. Even global body like UN is not able to intervene due to different vested interests of different countries.

While on the other hand small Pacific islands like Fiji, achieve peace through Talanoa Dialogue which has been accredited even at international level by incorporating it in UNFCCC.

The above examples show how reaction or no reaction from

International community can minimize or escalate the conflict. Any situation in international arena can thus be turned upside down with each other's support. In this essay, we shall discuss the meaning and significance of international cooperation and how multilateralism is indispensable in ensuring peace and economic growth.

International Cooperation generally starts with the formation of independent nation states who are sovereign and capable of decision making through cooperation. Sovereignty is important as many nations initially were part of some colonial power and thus had no independent voice.

In ancient times, India was a prosperous nation with its cotton clothes exported everywhere and famous for spices. Thus rich ancient heritage caught the eyes of Britishers and India became a colony for more than 200 years.

India was an ombudsman of different religions as Hinduism, Jainism, Buddhism originated in India and spread to different countries thus leaving our influence on others. Post World War 2, independent nations emerged and many of south east Asian countries could feel closer to India due to ancient cultural ties. World War 2 teaches us about devastation also by use of nuclear powers over Japan.

Subsequent decolonization of countries was an important event where the countries rose against the hegemony of colonial powers. India was influential as it played a key role in formation of NAM and played a global geopolitics like Korean war.

With the end of world war, came the formation of UN which was a beacon of multilateralism in 1945. UN has been responsible as a deliberative platform on international agendas with respect to development, peace, security, climate change, diseases etc.

There are many other organizations that emerged for a specific cause but are equally important
Bryg → IMF and World Bank emerged after Bretton Woods

Agreement in 1944 and are responsible for maintaining financial stability across the world. Role of WHO has become extremely important as well as controversial due to pandemic. Similarly, importance of International Court of Justice (ICJ) and Permanent Court of Arbitration (PCA) cannot be undermined in light of conflict between nations on boxes, human rights violation and disputes over south China sea.

Countries have forged alliances based on their shared interests.

For G20, BRICS, ASEAN. But among all of these, European Union deserves special credit as it is sole coordinating agency dealing with shared economic and political

interest. It has inspired other international collaborations like RCEP, Pacific Pumas etc for trade and commerce development.

In spite of above success, multilateral organizations have faced immense troubles on different issues.

Modern history is impacted by World War between US and USSR.

till today as the tension increases in Afghanistan. The multipolar world imagined through the

creation of UN became bipolar. In the end, US emerged as a

single superpower, whereas USSR disintegrated into smaller countries

that are still struggling.

USA maintained its hegemony with interference in many countries like Vietnam, Somalia. It also interfered

in multilateral organisations like WTO where the dispute settlement body became ineffective due to continuous veto against the election of members.

But recent emergence of China has become a threat to the hegemony of USA. But this economic prowess of China fails in the face of dire human rights violations and denial of democratic rights.

China has impacted the sovereignty of south East Asian countries by building artificial islands in South China sea and affecting sea lanes of communication ignoring the UNCLOS ruling. While USA has recently breached India's territorial waters under its Freedom of Navigation operations.

The deal between USA & USSR in START treaty fell through due to both sides blaming each other. Similarly, Refugee crisis across the middle east has now become normal as not many countries are involved in humanitarian help.

With such background, alliance formation is the most natural outcome among the global powers. We have seen how US led mediation in Israel-Palestine conflict have always sided with Israel and recently many Arab nations recognizing Israel (e.g. Bahrain, UAE) while similar mediation by USA in favor of Taliban as a legitimate government in Afghanistan were doomed to fail.

China has similar launched
humongous OBOR initiative to
revive its old silk route to maintain
and gain new allies. But it has
been called debt trap diplomacy
as countries like Sri Lanka, Pakistan
have been forced to lease out
land due to non-payment of debts.

Thus, alliances in
geopolitics are never permanent
and they change with changing
interests. Sometimes, the
sovereign issues make it difficult
for few countries to come on board
even for a good cause. e.g. India's
proposed CCIT at UN has not
been accepted due to different
terrorist definitions to each country.
Also, UN reforms are long overdue
as they do not reflect the changed

geopolitics but veto of P-5 countries come in the way of showing any legitimate power

In the case of climate change, developed countries have not ~~at~~ shared even 20% of global committed to developing countries. Island nations and low income economies have themselves come up with many initiatives like Loss Triangle, LOFA but they have limited financial power and low share in international bodies like IMF thus their voice is not heard.

Solving the matrix

Let us now focus on providing concrete solutions as to how international cooperation can be used effectively to mitigate

long lists.

Firstly, major powers should stand away from meddling in internal affairs of countries. Also, diplomacy should be the way out of any crisis rather than direct attacks. Eg. killing of Gasssem Soltanmani of Jude by USF was the final blow to the Joint Comprehensive Plan of Action (JCPOA) Abraham Accords between Arab nations and Israel is a welcome move and should be replicated with Iran as well. Rather expansion of INSTA can also be considered.

Second, reforms in international organizations especially UN should be made at the earliest. UN has expanded from 40 member body to 193 members and thus

veto power should reflect that.
Recent mishandling of COVID-19
by WHO and delays in declaring
it a pandemic shows the
poison character of the body
which should be changed.

Reforms in WHO are long
overdue. Also, ~~former~~ hegemony
of superpowers at WHO has led
to concerns for developing nations.
For example dispute regarding
fisheries subsidy, compulsory
licensing should consider the
concerns of developing countries
organizations like OPEC
should come out of costalization
politics by avoiding price wars
smaller organizations like
CARICOM, African Union should

be given credence at international level.

Moreover, maintaining and respecting territorial sovereignty of neighbours should be the aim of all. It would lead to peace and trust-building and better international cooperation.

In this respect, Vasudeva Kutumbakam should be the guiding light for all future negotiations.

COVID-19 has taught the world how one region can impact the economy, livelihood and above all, the health of an individual anywhere on earth. We need to be proactive in reaching out to others and provide support. Vaccine diplomacy through COVAX, GAVI concept of one Health against zoonotic epidemics have been

giving us a ray of hope that
cooperation will only lead to
betterment of world social order.
Multi-lateralism is the key to
have achieve the common goal
of economic growth
